## Maestas Taekwon-Do School Challenge 18

## **General Information**

Students may register the day of the event. However, there is a \$10.00 late fee added, must be paid

in cash and as soon as check in opens.

Maestas Taekwon-do will pay the Apex entrance fee of all officials and competitors. All spectators, regardless of age, must pay a \$5.00 Apex Center entrance fee. The fee covers use of all facilities of the Apex Center (except for Ice). Wrist bands will be available for purchase during in. Visit http://apexprd.org/facilities for more information on the Apex Center.

Competitors will compete to earn points for their schools. Schools with 5 or more competitors will compete for the title of Maestas Team School championship school. Individuals will compete in their own division (individual sparring, individual patterns, and individual power breaking) to earn points towards the school championship.

This event is open to all color belt (10<sup>th</sup> Gup white belt to 1<sup>st</sup> Gup red belt) and black belts (1<sup>st</sup> Dan to 5<sup>th</sup> Dan) students. Competitors are automatically registered for sparring, patterns and breaking. If a student chooses not to compete in one event they will be scratched from the bracket. Maestas TKD reserves the right to adjust brackets as necessary to make the event as fair as possible. Individual breaking consists of one power foot break. Modified side kick is ok. The breaking material is plastic.

Each Taekwon-Do school may enter as many competitors as it wishes (minimum of 5 to qualify for the school championship). We encourage each school to have signs, banners and school spirit to identify its members. Each school should bring a sign to be held by one person with the school name and school location (no larger than 24" x 24" please). We encourage all students to preregister by March 10<sup>th</sup>. We will take late registrations on the day of the event but competitors must pay in cash and as soon as registration opens. A \$15.00 additional fee will be charged for same day registration.

This year we are adding team breaking and team patterns. Each school may enter one team for team breaking and one team for team patterns. Team members can be the same for each team or different. Team members must register and compete in the individual part of the tournament (individual patterns, sparring and breaking).

Team breaking – three member teams. The breaks are front kick, turning kick and side kick (modified side kick is ok). Team score is determined by the total number of board broken by the team.

Team patterns – three to five member teams. They may perform any pattern no more advanced than the lowest ranked person on the team. It can be any pattern lower than the pattern of the lowest ranked team member. Only one team per school.

Patterns and breaking team members must register for the individual part of the tournament and are expected to compete in individual events.
